Driver's and co-driver's disclaimer of liability in the event

The participants take part in the event at their own risk. They carry the sole responsibility according to civil and criminal law, insofar an exclusion of liability is not agreed in this invitation.

They assure that the vehicle fulfills all technical requirements stipulated in the regulations and that the vehicle used in the event will be technically and optically in a flawless condition.

Driver and co-driver waive a claim for any damage that should occur in connection with the event, in particular against

the organizer Offroad Solutions Ltd., Schalber Event GmbH, their managers and employees, sports attendants as well as owners of property on which events take place,

patrons and sponsors,

authorities, emergency services and all other persons natural and incorporate, linked to the organisation of the event,

road building authorities as far as damages occur due to the condition of roads, tracks and areas, including any related equipment used during the event, and

vicarious agents and officers of all aforementioned persons and posts,

apart from damages caused maliciously or by gross negligence.

These provisions shall not apply to damages to life, body and health caused by a wilful and seriously negligent breach of duty (including a breach of duty committed by a legal agent or assistant of the persons released from liability) and to other damages arising through a wilful and seriously negligent breach of duty (including a breach of duty committed by a legal agent or assistant of the persons released from liability).

The waiver of exemption is valid for claims due to any legal ground, in particular for claims resulting from contractual and non-contractual liability as well as claims due to any tortuous acts.

All participants waive any claims against other participants, drivers, co-drivers, assistants, vehicle keepers, owners of the other vehicles as well as their own drivers, co-drivers and assistants (diverging special agreements between the vehicle owner(s), driver(s) and co-driver(s) shall override these provisions).

arising from damages occurring in connection with the event, exception to damages to life, body and health caused by a wilful and seriously negligent breach of duty (including a breach of duty committed by a legal agent or assistant of the persons released from liability) and to other damages arising through a wilful and seriously negligent breach of duty (including a breach of duty committed by a legal agent or assistant of the persons released from liability).

This waiver of liability shall be valid for claims arising from any legal ground, in particular for contractual and non-contractual liability claims for damages as well as for claims arising from tortuous acts.

Any implicit disclaimer of liability will remain unaffected by aforementioned non-liability clause.

The event manager is responsible for the contents of the regulations. Offroad Solutions Ltd. will not assume liability if the driver does not accept the event manager's regulations and therefore refrains from participating or if the event manager denies registration to the participant.
